There still seems to be some confusion about the annual dues and insurance. I hope this can help to explain the process:

On December 31st I will send out the membership renewal forms. The renewal process automatically sends an email to each club to let them know it is time for SFMS membership renewal.

The email addresses used for the email are determined in this order:

- 1. From the club contacts list president and treasurer.
- 2. If there is no contact information for the president or treasurer, any other contacts found are used.
- 3. If no contacts are found in the club contacts list, the email addresses in the 2024 All Clubs Membership Dues and Insurance spreadsheet left from the prior year are used.

If there are no email addresses in the membership spreadsheet, the email is sent to the state director with a message letting the director know that the SFMS does not have contact information for the club.

The person designated by the club then fills out the online membership form with the following:

- Their name
- Their email address
- Their phone number
- Name of the person responsible for paying the dues

- Email address of that person
- Phone number of that person
- Number of adult members you had on the roster for 2024 as of 12/31/2024

Number of junior members you had on the roster for 2024 as of 12/31/2024
You must also indicate if the club intends to enroll in SFMS liability insurance:

- Yes
- No

Have other insurance If you choose "Yes", you have the option to enter up to two show dates to enroll in SFMS show/event insurance. Otherwise, the form goes straight to the submit button.

Then submit the form.

Once the form is submitted, a confirmation email is sent to the following people:

• The person who submitted the membership renewal form

The club Treasurer

Please make out the check to SFMS and mail to the address on the form. This check is for dues only. Insurance is paid separately from membership dues because the insurance rate is determined based on the total number of members reported under membership renewal and whether or not you require show insurance. When the insurance rates are available, the assistant treasurer will send an invoice for the insurance with instructions.

Well, Helene's name will be retired after this year's hurricane season ends. And many folks will be haunted forever, unfortunately. Latest news is really heart breaking, too many lives lost, too many homes and businesses destroyed and too much of our infrastructure damaged.

We live in upstate South Carolina and much of this area is a real mess. Too many power lines down thanks to trees that were such a beauty on Thursday morning. Friday afternoon, many were severely damaged.

We lost power just before 6:00AM on Friday morning. We thought we were prepared; we were woefully shy of being ready. Our list of failings included parking the cars close to the house and did not park one close to the street. The result was three trees down across the driveway and now we were isolated. We had discussed that late Thursday afternoon and rationalized, that we would be OK, oh well, first major decision that did not pan out.

Next was forgetting that I had not started the portable generator since summer of 2023. This was a real baddy, here on Friday afternoon, the storm had passed, and the generator reminded me of this failing. Now, this would not have solved the problem, since I had one gallon of new gas. I had 5 gallons of 2-year-old gas, which should have been properly disposed of a year ago. So, if it had started, we had no way to get more gas on our own.

So, here we are with no way to get anything on our own and a generator that I could not restart

thanks to my NOT being prepared. And here I have been emphasized being prepared in this article for the last several years, except for the extreme hazard called Helene. Humiliating, you bet, did not mind my own warnings.

As we headed to the airport thanks to a neighbor who was not isolated, it took over 2 hours to get there. She needed gas and we stopped at several stations on the way to the airport. We got within 2 cars of the pumps at 3 stations to find the stations had run out of gas, DIESEL ONLY. She got us there and after standing in line for over an hour we got our car. It seems way too many of us had forgotten to be prepared.

And with all that we have been through, our woes are significantly TINY compared to many folks and we are very lucky to have been able to escape thanks to a neighbor that got us to the airport to pick up a car and escape to north Georgia. A neighbor in Georgia provided the information that the area had only a glancing blow from Helene.

Our hearts go out to families so distraught by Helene. Many of us are extremely happy to have good neighbors that help in times of crisis.

God bless all and warnings of pending disasters are good, and, when you have 15 inches of rain and wind gusts of 70 miles per hour, those of us not used to this may NOT take the warnings as possibly being catastrophic.

Take care of yourself and each other, as one evening newscaster notes.

Rock Corner by David Liles (Knoxville G&MS)

Documenting Rare and Special Finds

Hi Folks! This month's column is kind of a follow on to last months in that I am again discussing a find I made while on a 2020 Knoxville Gem and Mineral Society (KGMS) field trip to collect fossils and rocks at a Middle Tennessee location. I am going to discuss my unusual find of blue lace agate. I will also touch on how one should document unusual rock, mineral, fossil, and artifact finds so that knowledge of such is not lost to future generations.

I was asked not to be specific about field trip locations in articles that can be easily accessed by non-club members, which in this case includes those NOT members of the Knoxville Gem & Mineral Society. Apparently, the public can see the Lodestar and read the articles there. We want to avoid a situation where irresponsible people abuse collecting privileges, leading to blanket closure of collecting sites. Examples of abuse we want to avoid include excessive digging, leaving trash, destruction of the site and collectables. Along with this often comes aggressive and irresponsible "Collecting and Digging Prowess" displayed on U-Tube videos, Facebook, and other social media outlets. Anyway, you get the picture! Ok, now on to a discussion of documenting a special find without revealing the collecting site to non-club members.

In 2020, I made an unusual find on a Knoxville Germ & Mineral Society field trip. I found a piece of blue lace agate in a hard sandstone matrix! Our field trip leader, Daniel Miller, said that he had never seen this at this site in the 30 years he has been leading field trips there! This was my 1st and only find of agate in the 5 years I have visited the site.

Common finds in this area include crinoid fossils, both as individual pieces, and as masses of pieces in rock. The fossil mineralization material

for individual fossils, and masses of fossils is quartz, with colors ranging from white to rust to burgundy to blue – depending on the type of trace minerals in the quartz. The most common colors seen for the crinoid fossils are the white and the blue. Also, there are also a lot of rocks in the area, including this one, that appear to me to be hard brown sandstone. A typical example looks and feels like sandstone. It can be scratched with a penny and a piece of steel, but it can in turn scratch glass, with the loss of a few grains of sand. There is no reaction to acid, so my example does not appear to contain carbonate minerals (limestone would be the most likely). This sandstone is hard, and sand grains do not easily rub off.

My theory is that older quartz sand sandstone in this area was made harder by later partial quartz mineralization, that served to further bind the sand grains together. This probably happened at approximately the same time that the crinoid fossils in the area were mineralized, via quartz replacement of the original calcium skeletal material (aragonite). See: https://en.wikipedia.org/wiki/Aragonite.

In my opinion, a crack in my piece of the original sandstone allowed for the circulation of quartz bearing mineralized water. This solution subsequently deposited layers of white and blue quartz – to line in and fill the void in the sandstone. Because a crack is filled, the cracked stone is the older rock, and the rock filling the crack is the younger. This formation of agate must have been a unique coming together of circumstances and conditions, since only one example (that I know of) has been found.

Now, ... Case in point – what to do with a special find! What usually happens when someone finds an unusual rock, fossil, or artifact? Well, the discovery is most often removed from the site where it was found and taken home by the finder. Initially, there may be some display and bragging to others about the find and the finding process. In most cases, the object ends up languishing in a box or drawer. There is no written documentation (Provenance & Provenience) concerning where and how the object was found, who found it, and who has owned it. The person who did the finding believes that he will either never die, or that he will get around to documenting the finding later. Well, in many cases, "later" never comes, and the details of the find die with the passing of the collector. The object, unless obviously otherwise collectable to others, becomes just another rock or fossil for someone closing an estate to toss out back into a ditch, or to give or sell to another collector.

Some definitions by Wikipedia:

"Provenance": "The primary purpose of tracing the provenance of an object or entity is normally to provide contextual and circumstantial evidence for its original production or discovery, by establishing, as far as practicable, its later history, especially the sequences of its formal ownership, custody and places of storage. The practice has a particular value in helping <u>authenticate</u> objects. Comparative techniques, expert opinions and the results of scientific tests may also be used to these ends, but establishing provenance is essentially a matter of <u>documentation</u>."

There is also a related term "**Provenience**": "In <u>archaeology</u> and <u>paleontology</u>, the derived term **provenience** is used with a related but very particular meaning, to refer to the location (in modern research, recorded precisely in three dimensions) where an artifact or other ancient item was found. *Provenance* covers an object's complete documented history. An artifact may thus have both a provenience and a provenance. See

(https://en.wikipedia.org/wiki/Provenance).

Ok, the above definitions of "Provenance and Provenience" set the standard for documenting special finds! Discussing my agate in this Rock of the Month column is part of my effort to document my finding. Proper documentation can include:

- Taking pictures of the find as it was discovered before collection, and in detail later at home after cleanup. If you can, get GPS coordinates.
- Mark details of the find where and by who on the object itself with paint or permanent ink. Do this only if the object is not damaged by the process,
- Create a written story of your find, print that out, and store that with your find in its own separate storage container,
- Try to get the story and pictures of your find published in some way that can be found by others now and after you are gone,
- If you find something special on public lands, be aware of the laws on collecting and possessing. In any case, photograph the item in place and share the photo and info with park officials. Your finding may make a real difference in research and knowledge of the area and its past.

Remember, document your special finds, but be careful who you tell, so that collecting sites are not abused and ruined. Also, be aware that the inconsiderate actions of a few have resulted in the loss of collecting sites for all rock clubs and responsible individuals.

Well until next month, have fun & keep looking at the ground! That is where the rocks (and fossils) are, I hope you find something special!

Three Financial items for Consideration and Vote:

1. Guidelines for travel reimbursement to the AFMS annual meeting

SFMS covers two members to attend the AFMS meeting. President and 1st VP or their designated alternates. All expenses must have legible receipts, with date, place and action, furnished to the SFMS treasurer before funds will be released. Not a list of expenses but the original receipts or copies of these. The reimbursement will be based on www.GSA.GOV >Travel rate @ https://www.gsa.gov/travel/plan-book/per-diem-rates

Modes of Transportation:

Mileage, if traveling in a privately owned vehicle. This will be determined the Federal governments rate of reimbursement. Miles traveled will be determined from their home address to the address of the hotel/meeting, using a standard computer-generated map guidance for the fastest non toll way.

Airfare travel will be economy only, upgrades will be at the traveler's expense. One paid piece of luggage and NO extra weight.

Per Diem Rate Standard: https://www.gsa.gov/travel/plan-book/per-diem-rates

Lodging daily rates, excluding taxes, will be based on the city where the meeting is being held. The number of days for lodging while traveling will be based on an eight-hour driving day.

Lodging expenses will be covered if staying at the suggested accommodation even if outside the recommended lodging rate but not to exceed the total budgeted amount.

We will cover cost of SFMS representatives who are attending meetings for hotel stay one day prior to meeting and one day after the meeting when, necessary.

M&I will be reimbursed based on the city where the meeting is being held. There will be a per diem daily per meal rate. Adjustment for banquet and breakfast cost in conjunction with the AFMS meetings will be made if it is more than the daily meal rate. Only expenses backed with receipts will be considered for reimbursement. No alcohol will be covered.

All adjustments to expenses should be addressed prior to attending the AFMS meeting with the executive board. Persons traveling as a representative of the SFMS at the AFMS annual meeting will need to fill out a travel reimbursement form and include all necessary receipts and send them to the SFMS Treasurer to be reimbursed.

2. Proposal for State Director Stipends

State Directors financial assistance for visiting the clubs/societies in their state using funds raised by the Rockhound Roundup. They were very interested in what we have to offer. I look for them to become very active very quickly. I would like to encourage every club to educate your members about the website. It is a good way to stay up to date and educated about the SFMS. If you need help doing this, please let me know. I be glad to help!

I was looking at the Club Contacts list recently getting ready to send 2025 Club Membership renewals in December for 2025. Very few clubs have updated the contact information since the original input. PLEASE, PLEASE!!! Have a designated person in your club start updating this so we can have correct information. I need to know who to send renewals to, so the process runs as smoothly as possible for all.

There still seems to be some confusion about the annual dues and insurance. I hope this can help to explain the process:

- -On December 31st I will send out the membership renewal forms.
- -The renewal process automatically sends an email to each club to let them know it is time for SFMS membership renewal.
- -The email addresses used for the email are determined in this order:
 - 1. From the club contacts list president and treasurer.
 - 2. If there is no contact information for the president or treasurer, any other contacts found are used.

- 3. If no contacts are found in the club contacts list, the email addresses in the 2024 All Clubs Membership Dues and Insurance spreadsheet left from the prior year are used.
- 4. If there are no email addresses in the membership spreadsheet, the email is sent to the state director with a message letting the director know that the SFMS does not have contact information for the club.

The person designated by the club then fills out the online membership form with the following:

- Their name
- Their email address
- Their phone number
- Name of the person responsible for paying the dues
- Email address of that person
- Phone number of that person
- Number of adult members you had on the roster for 2024 as of 12/31/2024
- Number of junior members you had on the roster for 2024 as of 12/31/2024

You must also indicate if the club intends to enroll in SFMS liability insurance:

- Yes
- No
- Have other insurance

If you choose "Yes", you have the option to enter up to two show dates to enroll in SFMS show/event insurance. Otherwise, the form goes straight to the submit button.

Then submit the form. Once the form is submitted, a confirmation email is sent to the following people:

- The person who submitted the membership renewal form
- The club Treasurer

Please make out the check to SFMS and mail to the address on the form. This. check is for dues only. Insurance is paid separately from membership dues because the insurance rate is determined based on the total number of members reported under membership renewal and whether or not you require show insurance. When the insurance rates are available, the assistant treasurer will send an invoice for the insurance with instructions.

They were merged for convenience back when the documents were all printed and distributed as hard copies. When the documents were converted to electronic form they were kept as a single document. After this happened it appears that any generic change that applied to both documents were voted on as if they were a single document.

Based on this, I've electronically separating the documents into two separate entities. From this time forward any suggested changes that effect both documents will have to be provided as two separate submittals and voted on as two separate documents. Any suggested change that affects a single document with must be submitted and voted on as a separate document.

BYLAWS REVISION = Sept 2024

The following changes have been requested, in writing by Vonda Echols, in time to be officially submitted for review/vote. The changes listed below allows the option of having a special event instead of a gem and mineral show, if circumstance warrant.

The following changes in RED reflect the request:

Article VI - ANNUAL MEETING

Section 1 – Annual Meeting

The Federation shall hold at least one Annual Meeting each calendar year for the following purposes:

A. To hold the Annual Meeting in conjunction with a gem and mineral show or other special event which may contain exhibits by its members (if applicable).

Section 4 - Hosts

A. The Host shall have the primary responsibility for planning and preparing for the Annual Meeting. The Federation shall arrange its own program for the Annual Meeting and other special meetings. The Uniform Rules Committee shall perform duties as prescribed in the By-Laws for the Show/Special Event (if applicable).

Section 5 – Coordinator

The First Vice-President of the Federation shall act as coordinator for the Federation and Host, and shall keep in close communication with the Host General Chairman on all planning preparation, activities, and developments involved with the Annual Meeting and Show/Special Event. The First Vice-President shall meet with the General Show Chairman as early as possible.

Section 6 – Host General Chairman

A. HOST GENERAL CHAIRMAN DUTIES

The Host General Chairman, with the assistance of the SFMS Coordinator (First Vice-President), shall draw up tentative plans for the Annual Meeting (Show/Special Event, Banquet, and Editors' Breakfast). The Host General Chairman then shall submit the tentative plans to the proper authorities in the Host Club or Society for their Approval. After the approval of the Host Club or Society, the Host General Chairman and the SFMS Coordinator shall work together to follow through with the plans for the Annual Meeting.

Section 10 – Show/Special Event

A Special Event shall consist of:

A. An event that is of interest to the membership and is related to the mineralogy, lapidary arts, paleontology, geology, archaeology, and any related Earth Sciences. These may include, but are not restricted to, auctions, rock swaps, etc.

B. Where applicable, an assemblage of displays of collections related to the subjects of mineralogy, lapidary arts, paleontology, geology, archaeology, and any related Earth Sciences shall be setup at the event.

C. Where applicable, the public for the purpose of advancing public education and arousing public interest in the Earth Sciences, may attend the special event.

D. The First Vice President along with the Host General Chair shall determine the type of event and whether the event is applicable for public attendance and/or displays.
